Online submission of practical and internal assessment marks to University is followed according to University notification. Ongoing internal evaluation is done through assignment, group discussions, quizzes and participatory activities. Subject faculty assesses the students internal performance in the manner prescribed by the university. In a semester, 2 assessment tests are conducted and assignments are given and evaluated continuously. CCE answer sheet and marks are shown to the students and guided for improving performance in future. Students are given various classroom activities and homework exercises as review for exam and class discussion. Journals are available for the PG students to update their knowledge and inclination towards research. Students feedback is collected periodically through answering specific questions about the instruction and self evaluation performance and progress of the institution.

The academic year commences with the preparation of the academic calendar. As the college is a govt. affiliated institution, it has to adhere to the academic calendar of the department of Higher Education of MP Govt. Since it is a govt. college, therefore the maintenance and improvement of the building is undertaken by the P.W.D, of the State Government. The college development committee/building committee along with Principal also monitors the

construction work with P.W.D. The college also utilizes funds from U.G.C. and College development fund of Janbhagidari committee to utilize for maintenance and minor repairs of furniture and equipment. Maintenance of computer. and college website is monitored. Aqua guard and water coolers are maintained on cash payment basis as an when required. The departments take the initiative to calibrate the precision instruments for the optimum and assured performance. This exercise is particularly done in the beginning of the academic year and before the semester examination. The college has clear cut identified places for the sensitive equipment like electricity, generators, water purifiers and other electronic equipment. The laboratory staff keeps strict vigil in maintenance to keep instruments up to date. The college supporting staff is responsible for the maintenance and up keep of classrooms and library. The institution regularly maintains the water purifier so that water quality remains good. Maintenance is done periodically to facilitate uninterrupted functioning of system/electronic appliances. Fire extinguishers are kept at major places.
