The policy of the institution is to develop infrastructure facilities for effective teaching and learning. The existing physical infrastructure facilities have been expanded to meet the growing needs of the institute to capacitate increase in strength of students. In order to enhance the infrastructure, the policy is framed according to the rules and regulations of state government and the governing body of the college. The college has sufficient infrastructural facilities and resources to conduct curricular, cocurricular and extra curricular programmes and activities with proper planning and requirement. The institution approaches UGC, MP Govt., College Janbhagidari Samiti (Public Participating Committee) to seek various funds to strengthen infrastructure. Continuous growth of the infrastructure, renovation and maintenance is done with the help of PWD. The college campus is over 4.33 acres of land with a constructed/built-up area. There are buildings such as- main office building, Arts and Commerce building and Library block. There are 20 class rooms with proper light arrangement and ventilation. All the departments of the college have been provided computers, LCD, Projector, 100 MBPS internet connectivity. The college has five smart classrooms with the provision of Wi-Fi connectivity. It annually reviews the computer requirement of the college. College website is maintained and updated time to time by IT committee and students get latest information related to them. The institution encourages the staff to undergo training for computer aided teaching. The computer department also organizes training session for the use of internet for learning resources. Projects and assignments with the help of computers allows multiple ways of learning. Library and Sports are given impetus in order to give students good physical health, training and mental health.

The College is Polythene free from usage. Plantation is done regularly, Percolation pit - Usage of percolation is done. Compost pit of waste material is in use. Systematic e waste management is done.

7.2 - Best Practices

7.2.1 – Describe at least two institutional best practices

1. A percolation pit is nothing but a hole dug into the ground. It helps draw water downward through the soil, recharging groundwater. The pits have been dug scientifically in order to check waterlogging and soil erosion during heavy rainfall, In our college a study was planned to design a percolation pit to harvest rain water and recharge ground water. Aquifer improves and maintains the ground water quality of wells located along the Dewas region. The study recommended the construction of percolation pit near borewell in the available natural depression/monsoon rain. The size of pit is 4.0 m Long x 3.0 m wide x 2.0 m deep, along with 200 mm PVC strainers pipes up to 12 m depth inserted before digging the pit. The pit costing Rs. 13500 approximately, caters the macro water shade area of approximately 2 ha. Hence, the study was planned to design percolation pit to vertically drain the stagnate water during monsoon and harvest rain water for improving the ground water quality. 2. Systematic e waste management of waste material is done constructively.
